PLAYGROUND POLICIES

1. Children shall be supervised by an adult (18 years or older) or legal guardian at all times.
2. Children OVER the age of 12 years old are not permitted to use playground equipment at any time.
3. Playground hours are from dawn until dusk. Residents will be asked to leave if they are on the playground after hours.
4. Absolutely no glass or alcoholic beverages are allowed within the playground area.
5. Any items left on the playground will be turned in to the Cabana Area Guard lost and found and will be kept for a period of one week. The items will then be discarded.
6. No pets are allowed in the playground area, with exception of certified service animals or seeing-eye dogs.
7. Any damaged or unsafe equipment shall be immediately reported to the District Manager.
8. No smoking shall be permitted in the playground area.
9. Use of profanity will not be tolerated.
10. Violations will be subject to suspension as deemed appropriate by the Board of Supervisors.
11. Call 911 in the event of an emergency.

RECREATION AREA POLICIES & PROCEDURES

1. The swimming pool facilities are open from ½ hour after dawn and will close at dusk.
2. Each membership household may bring up to THREE guests for use of the pool facilities but must accompany their guests at ALL times.
3. Lifeguards will not be present at the pool facilities. All persons using the pool and other Swim Club facilities do so at their own risk.
4. Children under the age of 18 must be accompanied by an adult at all times while using the pool facilities.
5. Parents are responsible for ensuring that their children do not urinate or defecate in the pool. (Rubber briefs MUST be placed over diapers)
6. All persons using the pool facilities shall obey the capacity requirements as defined by Pasco County (90 persons for the pool).
7. Proper swimming attire must be worn while using the pool facilities. (Bathing suits only)
8. Showering is MANDATORY before use of the pool facilities.
9. No running is allowed within the gated pool facilities.
10. No diving is allowed.
11. No flotation devices are allowed in the pool except for water wings used by small children.
12. No rough housing, "chicken" fighting or horseplay is allowed in the swimming pool.
13. No balls or toys should be thrown within the pool or pool area.
14. No animals are allowed in the pool facilities.
15. No food or drink is allowed within TEN FEET of the pool edges(s).
16. No smoking shall be permitted in the pool area.
17. No alcoholic beverages are allowed in the pool facilities.
18. No glass containers are allowed in the pool area.
19. Radios brought to the pool shall be kept at reasonable volumes in consideration of others using the pool facilities.
20. Pool furniture shall not be removed from the pool deck area or placed into the swimming pool.
21. Non-compliance to these (Pool) Rules will result in the suspension of pool use by offender(s).
22. Call 911 in the event of an emergency.
23. No rollerblades/in-line skates or skateboards.
24. Use of profanity will not be tolerated.
25. Violations will be subject to suspension as deemed appropriate by the Board of Supervisors.
26. Basketball/ Tennis Courts will remain open until 10:00 p.m.
